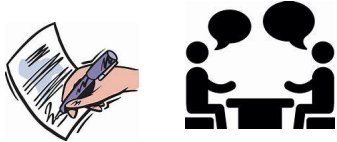

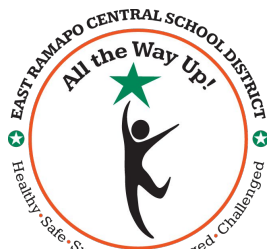

Proof of Residency – You must provide at least one form of proof of residency from list A **or** B, **and** C from the document list, below.

A. Homeowner/Condominium owner Mortgage statement; Deed; or Closing Papers

OR

B. Renter/Tenant Lease; Affidavit or unsworn statement by landlord;

Affidavit or unsworn statement by owner or tenant from whom parent/person in parental relation leases or shares property; or Statement by any other party establishing parent(s)'/'person in parental relations' physical presence in the District.

AND

C. Other Documentation of Residency: Please provide at least **one additional** document demonstrating residency if available. Below is a list of examples of documentation that may be used. The District will consider other kinds of documentation.

- Income tax form;
- Utility (such as gas/electric/oil bill, e.g., Orange & Rockland);
- Other bills (such as water bill (e. g., United Water), home telephone bill (e.g., Verizon, Optimum, etc.), cable TV/Digital TV bill (e. g., Cablevision, Direct TV, etc.) or Broadband/Internet service provider bill (e. g., Verizon, AOL, etc.);
- Membership documents (e. g., library cards) based upon residency;
- Voter registration document(s);
- Official driver's license, learner's permit or non-driver identification;
- State or other government issued identification;
- Documents issued by Federal,
- State or local agencies (e. g., local social service agency, Federal Office of Refugee Resettlement);
- or Evidence of custody of the child, including but not limited to judicial custody orders or guardianship papers.
